A Double Q ribbon will be given to any dog qualifying in both JWW & Standard.

NOTICE TO EXHIBITORS

- ◆ **Carry in of food and beverages is PROHIBITED by the facility! THANKS IN ADVANCE FOR YOUR UNDERSTANDING & COOPERATION !!**
- ◆ The trial will be held indoors on Mondo Synthetic Turf. The standard ring will be 94' x 120'; the JWW ring will be 60' x 140'. The Excellent FAST class will be in the Standard Ring, and the Novice & Open FAST classes will be in the JWW Ring.
- ◆ Any exhibitor whose bitch has come in season, or whose dog is injured, after the closing date may obtain a refund of his/her entry fee (less \$12.00 per dog per day) upon presentation of a Veterinarian's certificate to the Show Secretary prior to the start of judging for any class the morning of the show. Such refunds will be mailed 2-4 weeks after the trial.
- ◆ The handler will be solely responsible for having the dog at ringside when scheduled. If conflicts are anticipated, please notify the gate steward prior to judging for the class.
- ◆ Judges are not required to wait for any dog holding up a class.
- ◆ If, because of riots, civil disturbances, or other acts beyond the control of HDTC, it is impossible to open or to complete the trial, no refund of entry will be made. HDTC will not be responsible for loss or damage to property while on show site.
- ◆ Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Ohio law requires proof of current rabies vaccination.
- ◆ **The trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds.** Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.
- ◆ ALL DOGS MUST BE ON LEASH, CRATED, SECURELY PENNED, OR OTHERWISE UNDER RELIABLE PHYSICAL CONTROL AT ALL TIMES WHEN NOT COMPETING OR WARMING UP.
- ◆ Waterproof material must be placed on the floor under all crates and exercise pens in crating area.

- ◆ Please print legibly on entry forms, taking special care to note that your email address will be clear to someone who doesn't already know what it is. **Use a valid email account only!**
- ◆ IN CASE ENTRY CAN ONLY BE PARTIALLY FULFILLED, Trial Secretary will honor requests to return entries if one of the requested classes is unavailable. Such requests MUST be indicated on the entry form.
- ◆ Except as noted above, no entry will be accepted which carries any conditions regarding its acceptance.
- ◆ Entries received without fees will not be accepted. Post-dated checks, unsigned checks, and returned checks do not constitute payment of fees. A \$25 service fee will be assessed for any returned checks.
- ◆ **Entries MUST be submitted on an official AKC entry form including the COMPLETE "Agreement" page.**
- ◆ Unsigned, incomplete, or illegible entries WILL be returned, as will entries received prior to 8:00am April 12, 2010.
- ◆ **NOTE MIXED BREED EXHIBITORS: You should list "Canine Partner" for the breed name on entry form. No other breed description may be used to identify a mixed breed entry. Also, you must provide your AKC Canine Partners listing number on entry form, and check mark "AKC No." on form.**
- ◆ Entries for a maximum of ten (10) dogs are allowed in each envelope submitted to the Trial Secretary for random draw. Envelopes containing entries for more than the ten (10) dog maximum shall be treated as an invalid entry and shall be "Returned to Sender".
- ◆ **JUNIOR HANDLERS** must complete the information on the front of the entry form, and read the back of the entry form. Junior Handlers must include junior handler number in the box labeled "Handler". If you do not have a junior number, contact AKC (see back of entry form) or the Trial Secretary for an application for Junior Handler number.
- ◆ Be sure to clearly and correctly indicate whether you are entering regular classes or preferred. A dog must show either in regular classes only, or preferred classes only throughout the course of the weekend; no day to day changes are permitted by AKC regulations.
- ◆ Dogs entered in Novice A which complete any AKC agility title prior to our closing date (May 5, 2010) must move to Novice B or Open classes for this trial. If you complete an AKC agility title after May 5, 2010, you may remain in Novice A classes for this trial.
- ◆ **PLEASE CHECK YOUR ENTRY BEFORE SENDING IT !** Most common problems are missing signatures, missing registration numbers, and not including the "Agreement" page. Any or all of these oversights will result in your entry being returned to you. So **PLEASE** check carefully!

MEASURING

Exhibitors must indicate on the entry form whether the dog has a valid permanent height card, a valid temporary height card, or needs to be measured. If no indication is given on the entry form, the dog will be placed on the 'Needs to be measured' list and armbands will be withheld.

For details on changes to height card policy, see "IMPORTANT info for jump height cards" link on the HDTC website (www.hamiltondogtraining.com).

Any dog which has not been officially measured for an AKC jump height card must be measured by the measuring official *prior to running*. If a measurement is necessary, it is the exhibitor's responsibility to present the dog for measuring at the scheduled time. Check-in and Measuring: 8:30-8:50 am Friday, or 7:30-7:50 am Saturday and 7:30-7:45 am Sunday.

MOVE-UPS

WRITTEN notice must be received by the Trial Secretary by 6:00pm, Monday, May 17, 2010. Email notice is acceptable provided it includes all of the necessary information (smithki@zoomtown.com).

Overnight move-ups will be accepted for dogs completing titles on Friday or Saturday. Move-up forms (available from the Trial Secretary) must be completed and turned in no later than one half hour after the completion of judging on the day preceding the move-up.

Moving from regular classes to preferred classes or from preferred to regular is a change of entry, not a move-up and will not be accepted after entries close.

AGREEMENT

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Mixed breed dogs enrolled in the AKC Canine Partners program may be eligible to enter all-breed AKC agility trials at the club's option. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 816-3776.
